Curriculum Report –

Solution was to not resign one of the bus leases. EPA requires the replaced bus to be sold or scrapped – we can’t do either with a leased bus. Mark asked the EPA what can be done – Mark may be able to submit a letter to make a change to his original bus selection to use one that we own.
